## CERTIFICATE OF AMENDMENT

## THE BY-LAWS

of

## JAMESTOWN COLONY HOMEOWNERS ASSOCIATION, INC.

The undersigned, being the duly elected, qualified and acting Secretary of Jamestown Colony Homeowners Association, Inc., a Texas non-profit corporation (the "Association"), does hereby certify the-following amendment to the By-Laws of the Association was approved by a majority of the members of the Association entitled to cast a vote either in person or by proxy, at the Annual Meeting of the members held on the 1 lth day of June, 2001, at which the requisite quorum was present, and which was duly called to, among other things, amend the By-Laws of the Association as set forth below:

Article IV, Section 1 of the By-Laws of the Association is hereby amended to read as

"Section 1. <u>Number and Term of Office:</u> The business and property of the Association shall be managed and controlled by the Board of Directors, and subject to the restrictions imposed by any law, by the charter, or by these Bylaws, the Board of Directors may exercise all the powers of the Association.

The number of directors shall be six (6). At the 2001 annual meeting three (3) directors shall be elected for a term of two (2) years and three (3) directors shall be elected to office for a period of one (1) year. The three (3) directors receiving the most votes shall be elected to the two (2) year term in 2001. Each subsequent year the number of directors shall be elected to fill the number of director positions open that year and the term(s) shall be two (2) years (i.e. 2002 three (3) director positions shall be open, 2003 three (3) director positions shall be open, etc.).

All other provisions of the By-Laws of the Association shall remain in full force and effect.


